##### MEMBERSHIP ELIGIBILITY

- ◆ Life membership has two categories: Ordinary Life Member and Associate Life Member.
- ◆ Ordinary Life Membership is open to any former students of Christ Church Secondary School whether they were from Dorset, Tyrwhitt or Woodlands locations, who have completed not less than 12 months in the School as a student and is 21 years old or above at the point of registration. They shall have the right to vote and to hold office in CHR Alumni.
- ◆ Associate Life Membership is open to any past and present principals and staff of Christ Church Secondary School whether they were from Dorset, Tyrwhitt or Woodlands locations. They will be in partnership with CHR Alumni but shall not have the right to vote and to hold office in the CHR Alumni.

##### MEMBERSHIP FEES

One-time subscription fees: \$200\* (Individual)

Payment for subscription fees may be made by CASH or CHEQUE payable to CHR Alumni.

##### TERMS AND CONDITIONS

1. **PAYMENT TERMS:** Payment of the full subscription fee is to be made by cash or Cheque issued payable to "CHR Alumni" upon submission of membership application.

**2. MEMBERSHIP APPLICATION :**

All fields in the application form must be completed accurately and correctly. Please attach the following with your application:

- a) 2 passport-sized photographs each of applicant.
- b) A copy of the particular page of your Christ Secondary School report book for Life Ordinary Member.
- c) A copy of any proof of your employment in Christ Church Secondary School for Life Associate Member.

**3. MEMBERSHIP APPROVAL & REGISTRATION:**

- ◆ Applications are subjected to approval by the CHR Alumni General Committee.
- ◆ The General Committee's decision is final.
- ◆ Applicants will be informed officially in writing upon the approval / rejection of their applications.
- ◆ Upon approval by the General Committee, the successful applicant will be registered as Life Ordinary Member / Life Associate Member of the CHR Alumni according to the name as provided in the application form.
- ◆ For unsuccessful application, the subscription fees paid in advance will be refunded.

**4. Applicant must have read, understood, accepted and acknowledged the constitution of CHR Alumni.**

**a. Membership:**

- **Transfer of Membership** – Membership is not transferable.
- **Termination of Membership** – There will be no refund of any payments made.

**b. Correspondence:**
